The Commission entertained comments from Russell Culotta, Debra Johnson, Colonel Fontenot and Baxter Welch in connection with the proposed rule revision of State Police Commission Rule 8.20(a). On motion duly made, seconded and passed, the Commission voted to amend the rule as follows:

8.20 Promotion.

(a) Subject to the provisions of Rules 8.9(a) and 8.9(c), each promotion shall be made by appointing one of the eligibles within the five highest final grade groups on a promotional certificate issued by the Director following competitive examination. If there are five (5) or fewer qualified applicants for a vacancy, the Director may declare a non-competitive situation and forego testing for that vacancy. In such case, the applicants

shall be rated "Eligible".

The Commission entertained, on an ex parte basis, the Motion to Proceed in Forma Pauperis filed in connection with the Appeal of Darrell Berry, Docket No. 91-04-P. On motion duly made, seconded and passed, the Commission voted to deny the Motion. Additionally, the Commission requested the appellant furnish more detailed information with regard to his earnings and living expenses. Upon receipt of the additional information, this matter will be placed on the Commission's agenda for reconsideration on May 17, 1993.

The public hearing of the Appeal of Robert E. Hilburn, II, Docket No. 92-24-0 was called. On motion duly made, seconded and passed, the Commission voted to appoint Norman Ershler as Referee for the taking of testimony in this matter. This matter was limited to a consideration of the Motion for Summary Disposition and Opposition thereto, with testimony being taken in connection with the issue of timeliness. Upon completion of the testimony, evidence and all arguments by the parties, the matter was taken under advisement, with a written decision to be forthcoming.

The public hearing of the Appeal of John B. Matte and Jesse S. Perry, Docket No. 92-25-S was called. Johnson were absent. Also present were Debra Johnson, Norman Ershler and Gilda Russ. Vice-Chair Christian departed the meeting at 10:10 a.m.

On motion duly made, seconded and passed, the Commission voted to approve the Minutes from the April 19, 1993 meeting.

The continuation of the public hearing of the appeal of <u>Jennifer L. Evans</u>, (Department of Public Safety and Corrections, Office of State Police - Troop A), Docket No. 92-20-S, was called. Upon completion of testimony, evidence and all arguments by the parties, the matter was taken under advisement, with a written decision to be forthcoming.

The public hearing of the appeal of <u>Johnell Temple</u>, (Department of Public Safety and Corrections, Office of State Police - Troop B), Docket No. 92-26-T, was called. By unanimous vote of the members present, the Commission voted to appoint Norman W. Ershler as Referee for the taking of testimony in this matter. The hearing was limited to a consideration of the Request for Summary Disposition filed by appellant and the Response thereto

filed by appellee. After considering the evidence (where appropriate), the law and the argument of the parties, the Request for Summary Disposition based on grounds 1, 3 and 4 was denied. The issues of discrimination, appellant's compliance with State Police Commission Rule 13.11(d) and the Request for Summary Disposition based on ground 2 were taken under advisement, with a written decision to be forthcoming. The remaining issues will be rescheduled for hearing.

As an item on the Director's Report, the Commission received a presentation from Lieutenant Booth relative to an amendment to State Police Commission Rule 6.16 (d). The proposal read as follows: However, upon a permanent employee attaining thirty (30) years of credited service, he shall be moved to the maximum of his pay range. The Commission received comments from Thomas H. Normile, Wanda Raber and Walter Smith in opposition to the proposal. After receiving all comments, and on motion duly made, seconded and passed, the Commission voted not to present the Rule change at a public meeting for adoption.

As additional items on the Director's Report, Ms. Johnson requested the members select an alternative date for the August 1993 meeting, inasmuch as the Commission staff would be out of town part of the week previous to the meeting and would be unable to deal with last minute meeting items. The Commission requested that the matter be discussed at the June 21, 1993 meeting, where all members could be present. Ms. Johnson also advised the Commission as to the status of the current budget, as well as the budget for Fiscal Year 1993/94. As regards Cadet testing, Ms. Johnson

informed the Commission of a meeting between Lieutenant Booth, Ms. Johnson and Herbert L. Sumrall of the Department of Civil Service, wherein it was requested that the State Police Commission be allowed to utilize the test for Cadet previously administered by the Department of State Civil Service. This request was denied by Mr. Sumrall, citing that Ms. Johnson was using the best possible vehicle for testing Cadet applicants. The possibility was also discussed of the necessity of charging applicants an "application fee" for applying and testing for Cadet. The Commission requested Ms. Johnson research the feasibility of charging for testing and report her findings to the Commission at their June 21, 1993 meeting.

The Commission entertained, on an exparte basis, the Amended Motion to Proceed in Forma Pauperis, filed in connection with the Appeal of Darrell Berry, Docket No. 91-01-P. Upon completion of reviewing the original Motion, as well as the Amended Motion, by unanimous vote of the members present, the Commission voted to deny the Motion to Proceed in Forma Pauperis.

At the conclusion of the Director's Report, and with there being no further business, the Commission adjourned its meeting at 6:15 p.m., until Monday, June 21, 1993.

The State Police Commission convened its monthly meeting at 8:30 a.m., on Monday, July 19, 1993, in the Conference Room, Eleventh Floor, Wooddale Towers Building, 1885 Wooddale Boulevard in Baton Rouge, Louisiana. Present were Chair James R. Conway, III, Vice-Chair Ollie G. Christian and Members Joseph T. Booth, Roane E. Hathorn and Clifford V. Johnson. Commissioner Helen E. Mendell arrived at 8:55 a.m.. Commissioner Richard N. Kinsey was absent. Also present were Debra Johnson, Norman Ershler and Gilda Russ.

The Commission convened its meeting at 8:30 a.m. for the purpose of entering into executive session to discuss personnel matters relative to Norman W. Ershler. At the conclusion of the executive session, on motion duly made, seconded and passed, the Commission voted to appoint Mr. Ershler as a part-time Deputy Director, in the unclassified service, at a monthly salary of \$1350-per month, reflective of compensation for a maximum of thirty (30) hours work per month, at a rate of \$45.00 per hour. permanent arrangement for legal services.

On motion duly made, seconded and passed, the Commission approved the Minutes from the June 21, 1993 meeting.

The Commission reviewed previously submitted writings by the Department of Public Safety and Corrections, Office of State Police and the Louisiana State Troopers Association, as well as received comments from Russell J. Culotta, Thomas H. Normile and Kenneth H. Norris relative to the amendment of State Police Commission Rule 11.23.1. On motion duly made, seconded and passed, the Commission voted to amend the Rule as follows:

11.23.1 Funeral Leave.

Probationary and permanent employees may be granted time off without loss of pay, annual leave or sick leave, when attending the funeral or burial rites of a parent, stepparent, child, step-child, brother, step-brother, sister, step-sister, spouse, mother-in-law, father-in-law, grandparent, or grand-child; provided such time off shall not exceed three days on any one occasion.

The amended Rule became effective July 19, 1993, with a transmittal sheet to be forthcoming.

The public hearing of the appeal of <u>Gregory V. Dawson</u>, (Department of Public Safety and Corrections, Office of State Police - Troop A), Docket No. 93-29-S, was called. By unanimous vote of the members present, the Commission voted to appoint Norman Ershler as Referee for the taking of testimony in this matter. Upon completion of testimony, evidence and all arguments by the parties, the matter was taken under advisement, with a written decision to be forthcoming.

The public hearing of the appeal of Merwyn D. Erwin, (Department of Public Safety and Corrections, Office of State

Police - Protective Services), Docket No. 93-31-S, was called. By unanimous vote of the members present, the Commission voted to appoint Norman Ershler as Referee for the taking of testimony in this matter. Upon completion of testimony, evidence and all arguments by the parties, the matter was taken under advisement, with a written decision to be forthcoming.

On motion duly made, seconded and passed, the Commission voted to hold two additional meetings in 1993, in an attempt to minimize the backlog of appeals awaiting hearing dates.
