

- October 6, 2003 letter to Bob Rachal regarding budget shortfall. To date, no response received.
- Chairman Duncan and Ms. Johnson's placed telephone calls to Andy Copplin and Bernie Boudreaux attempting to schedule a meeting with the Governor regarding budget shortfall. No return calls were received;
- Ms. Johnson provided part of the Monthly Budget Report (\$430,117);
- 2004 budget spread, existing operating budget;
- Total dollar amount remaining in each object code;
- Provided annual salary amounts for each employee, including percent of annual merit increases provided to employees;
- Discussion of fiduciary responsibilities of the Commission;
- Mr. Breaux advised that Department Heads, Secretary of Labor and the Secretary of the Treasury make \$80,000 a year; Labor \$82,000 or \$83,000 to run the whole Department;
- Ms. Johnson was instructed to request in the upcoming budget process the
  dollar amount to cover the rental of the conference room; and to break out
  budget request to cover office space and conference room separately;
- Informed that the recommended budget was due to the Division of Administration by November 3, 2003 for Fiscal Year 2004/05;
- Explanation of what specific cost areas and object codes are;
- Discussed the supplemental appropriation process;
- Advised that the current spending level would be maintained, despite the budget shortfall;
- Cadet examinations will be administered in October and December 2003 and January 2004. Will also administer new examination to candidates remaining on eligibility list following the hiring of the Cadet classes for No. 83 and 84. A moratorium on testing would begin in February 2004;
- Requested that the staff check with State Surplus Property for purchase of office furniture;
- Requested that Ms. Johnson submit a request to the Commission for merit increases for the staff prior to implementation;
- Promotional examinations will be administered in March 2004 only if the Budget Office assures Director that funds will be available; continue to pay

- proctors to administer promotional examinations;
- Ms. Johnson provided direct telephone numbers for Ms. Green and herself;
- Commission questioned whether or not we could charge applicants for participating in examinations;
- Ms. Johnson asked if any Commission members had any special request for inclusion in the 2004/05 budget. None were mentioned;
- Asked if Colonel Landry had any response to the budget letter to Mr. Rachal;
   none was received; and
- Provided a detailed breakdown of the costs for the 2003 promotional examinations.
