To: All Full-Time Permanent and Probationary Employees of  
the Classified State Police Service

Subject: Call for Special Election of the Classified Employee  
Member of the Louisiana State Police Commission

---

Pursuant to the authority contained in Louisiana Revised Statute 42:1409(C), the Director of the State Police Commission hereby issues the call for a special election to fill the unexpired term of the classified employee member of the Louisiana State Police Commission. This call is effective Monday, May 2, 2022.

The term of office for this position shall begin on **June 7, 2022**, unless a runoff is necessary, and will expire on **December 31, 2026**.

A candidate for the elected classified member position to the State Police Commission shall be a full-time, permanent employee of the classified State Police Service for a period of one year prior to the date on which he or she qualifies as a candidate.

In accordance with Louisiana Revised Statute 42:1403, thirty (30) names of permanent classified members are required to effectuate the nomination of a candidate; therefore, the nomination petition contains spaces for the required thirty (30) names and spaces for up to twenty (20) additional names. Please note that more than one petition may be used for the nomination process.

Classified members that are not permanent employees in the State Police Service will NOT be eligible to sign nomination petitions; however, they may cast a ballot in the subsequent election.

Nomination petitions must be filed and received by the Director of the State Police Commission no later than 4:00 P.M. on Wednesday, May 11, 2022. Nomination petitions may be hand-delivered to:


